Types of memberships include (check those which apply):

___Regular Membership - Individual - (\$25)- Open to persons 18 years of age and older who enjoy all the privileges of the club, including the right to hold office, sponsor, nominate and second and are entitled to one (1) vote. Regular Members are counted in the quorum for club meetings. A Regular Member may transfer at any time

to Associate Membership by written request to the Secretary, with any change in dues to be effective for the following year. Regular members are required to attend a minimum of two events annually, one of which must be a meeting. If at least two events are not attended, the member will be requested to convert to Associate Membership if he/she does not anticipate being able to fulfill the requirements to attend a minimum of two events annually, one of which must be a meeting. If at the end of the second year, such minimal requirement has not been fulfilled, the individual must convert to Associate Membership.

___Regular Membership - Household - (\$40)- Open to two (2) persons 18 years of age and older residing in the same household who will enjoy all the privileges of the club, including the right to hold office, sponsor, nominate and second and are entitled to two (2) votes. Children, from age 9 to under age 18, in the same household will have the same rights as a Junior Member. Regular members are required to attend a minimum of two events annually, one of which must be a meeting. If at least two events are not attended, the member will be requested to convert to Associate Membership if he/she does not anticipate being able to fulfill the requirements to attend a minimum of two events annually, one of which must be a meeting. If at the end of the second year, such minimal requirement has not been fulfilled, the individual must convert to Associate Membership. One membership application will be completed for each household. If there are other adults in the household, they shall be looked upon as welcome guests but not as members.

___Associate Membership – Individual - (\$15)- Open to persons 18 years of age and older who live outside of the club's area or who live in the club's area but do not anticipate regular attendance at meetings. An Associate Member shall be informed of all club meetings and activities, shall receive the club newsletter, may serve on committees and may participate in all club activities, but may not vote, hold office, sponsor, nominate or second, and is not counted in fulfilling quorum requirements. An Associate Member may transfer to Regular Membership by written request to the Secretary at the time of yearly membership renewal and dues payment.

___Associate Membership – Household - (\$20)- Open to two (2) persons 18 years of age and older residing in the same household who live outside of the club's area or who live in the club's area but do not anticipate regular attendance at meetings. An Associate Member shall be informed of all club meetings and activities, shall receive the club newsletter, may serve on committees and may participate in all club activities, but may not vote, hold office, sponsor, nominate or second, and is not counted in fulfilling quorum requirements. Associate Members - Household may transfer to Regular Membership by written request to the Secretary at the time of yearly membership renewal and dues payment. Children, from age 9 to under age 18, in the same household will have the same rights as a Junior Member. One membership application will be completed for each household.

___Junior Membership – (\$3)- Open to any person 9 years of age to under 18 years of age with parental consent. A Junior Member may not vote, hold office, sponsor, nominate or second and is not counted in fulfilling quorum requirements. At age 18, a Junior may convert to Regular or Associate Membership upon written request to the board by the Junior Member.

___Lifetime Membership - May be conferred by a majority vote of the board of directors on an individual who has been a long-time member, usually 20+ years, whose participation and service to the club are meritorious. Lifetime members shall pay no dues, but are eligible to vote and to hold office.

___\$10 Optional newsletter fee, if you'd like it mailed to you, as opposed to receiving it through e-mail or through the club website. It will be printed in black and white.

Sponsors: Endorsements must be made by two unrelated current BMDCHR members in good standing age 18 and older from separate households. They shall attest that, to the best of their knowledge, you will abide by the Constitution, Bylaws, and Code of Ethics of this club. Sponsors will return their forms under separate cover to the club membership chair.

Dues will be payable upon acceptance into the Club. Members elected January 1 through September 30 will pay full annual dues amount. After September 30, new members elected will pay the full annual dues amount but will be considered paid in full through the end of the following calendar year. Applicants rejected may not reapply within 6 months after such rejection and shall require two new unrelated sponsors from separate households.

Submission of this application indicates your willingness to support and participate in club functions and membership meetings, and also your agreement to abide by the Constitution, Bylaws, and Code of Ethics of the club.
